Stabling:

The Stabling fee does **not** include bedding, it is shown as a separate item.

The Stabling fee includes cleaning on departure. The WPNEC compulsory cleaning fee (\$30 per stable) is included in the stabling fee.

All stables will be padlocked at the time of your arrival. Please report to the Stable Manager for access. Stabling is available for competing horses only, from arrival on either Tuesday 7th or Wednesday 8th June 2022. Please note: we cannot guarantee stables for use as tack rooms.

Stable Bedding:

All stables will contain 7 bales of shavings for spreading on your arrival. Bales will be opened in the stables prior to your arrival to avoid any going missing. If you are bringing sponsored bedding you must 'opt out' when completing your entry on Event Secretary. Please email susan_mckay@bigpond.com if you are bringing sponsored bedding.

Stable Bedding can be purchased during the event from WPNEC (03 9741 7672) at \$12.50 per bale. To ensure same day delivery bedding orders must be placed with WPNEC by 12.00pm each day.

Hendra Vaccination & Bio Security Policy for horses attending Melbourne International 3 Day Event:

The organising committee and Equestrian Victoria have been advised by the FEI Veterinarians that all horses entering the event from North of Forster in NSW and from Queensland, or horses that have been in these areas in the 30 days prior must be vaccinated against Hendra. Accordingly, the Organising Committee gives notice that, in submitting your entry to participate in this event, YOU WAIVE ANY RIGHT TO SEEK COMPENSATION OF ANY TYPE FROM THE ORGANISING COMMITTEE, EV OR WPNEC OR ANY OF THEIR OFFICERS, SERVANTS OR AGENTS for any loss, injury or other damage arising in any way whatsoever, directly or indirectly from the presence of the Hendra virus in any horse or person attending the event or from any person or animal contracting any illness or disability, including death, from the Hendra virus, whether directly or indirectly or howsoever otherwise.

Off the Track prize for Best Performed OTT horse in each CCI section – Nominations must be made at the time of entry on Event Secretary.

ENTRY SCRATCHING Refund Policy: (refer to the FEI Approved Schedule, Page 11)

- Full refund less \$50 admin fee if scratched before entries close on 23/05/22 (5:00pm)
- From 23/05 to 06/06/2022 (5:00pm) Full Stable Fee, Facility Fee, Camping fee, Stable bedding fee (if the bedding has been delivered to the stable there will be no refund)
- After 5pm 06/06/2022 no refund

EVENT CANCELLATION POLICY:

Equestrian Victoria or the Organising Committee may cancel the event due to catastrophic conditions, disease or force majeure, or for any other reason at its absolute discretion. If the event is cancelled prior to commencement, for whatever reason, any refund will be determined at the absolute discretion of Equestrian Victoria, having regard to the direct or fixed costs for the event. This includes State, Territory or Commonwealth government travel restrictions, COVID-19 quarantine and isolation requirements. If the event is cancelled after it has commenced there will be no refunds.

EADMCP

On 1 January 2016, the FEI announced a new global Equine Anti-Doping and Controlled Medication Program (EADMCP). The FEI's swabbing program will run concurrently to EA's anti-doping and controlled medication program. Each horse entered into an FEI event will incur the FEI's Worldwide Equine and Human Anti-Doping program fee. You will be required to pay this to the Organising Committee at the time entry.

Each horse competing in a lower level event* will be charged CHF 18 or AUD \$26

Each horse competing in a higher level event will be charged CHF 25 or AUD \$38

Risk Management Conditions

The information set out within this document *must* be included in the Prize Schedule, Competitor Information and/or Official Program for your event/s. This information must be signed by event Organiser prior to an event and adhered to at all times.

1. Werribee Park National Equestrian Centre Committee of Management considers it a **privilege** that you are allowed to bring your dog to this venue. We insist you **keep your dog on a leash and under effective control** at all times.
2. Approved Safety Helmets must be worn at all times when riding
3. Cross Country obstacles must not be jumped/used unless a non riding level one coach is present.
4. Riding of horses bareback is **prohibited**
5. Riding of rugged and/or unbridled horses is **prohibited**
6. Any person may lead a maximum of two horses while mounted
7. Stallions must at all times be in the control of a person aged seventeen years or more, when led or ridden
8. Horses are not permitted within/upon the quadrangle (between the barn & Indoor 1)
9. Horses are not permitted near pedestrian door ways
10. Bicycles are not permitted in the Indoor Arenas or any stable block. Approved helmets must be worn at all times.
11. Bicycles are not permitted near doors designated as public entrances or exits
12. Motor Cyclist & scooter riders must wear approved safety helmets and hold the appropriate licence
13. Speed limits must be adhered to at all times, the speed limit at WPNEC is 10km p/h
14. Power leads must not be on the ground or over roadways
15. Construction of portable/tape yards is **prohibited**
16. Alcohol must not be consumed in the Indoor Arenas, unless purchased from the licensed bar located in Indoor Arena No 1
17. Please observe all signs at the venue
18. Horses must be tied in a safe manner. Horses must not be tied to unattached floats, wheelie bins etc.
19. No infrastructure to be erected on WPNEC Grounds without written approval by management prior to event.
20. Entry and Exit doors to Indoors Arenas are not be obstructed at any time.
21. Every event to book at WPNEC must provide its own first aid officials.

These conditions apply unless the Manager or the Committee of Management has given the discipline/event/activity concerned an exemption.

***Exemptions must be applied for in writing and will be only valid for the dates granted.**
